Trustee McCloy provided the following Assessor's report: We have had increased resident interactions due to the issuance of tax bills over the last month. The Assessment Team continues to work hard, efficiently and effectively to provide the best service possible to the stakeholders of Downers Grove Township. I have received numerous compliments from individuals who have worked with a member(s) of the team who have indicated the top level of service they have received.

9. Highway Commissioner Report:

In the past month the Highway Department has been working on the following projects:

- * Our tree crew finished our spring brush pickup in sections four and five bringing our spring pick up to a close.
- * Our mowers finished the first round of mowing on the township right of ways. We usually mow three times a year depending on weather and workload.
- * We finished our first round of ditching with our Gradall contractor in early June. During this round we reset grades on several ditches, installed a few French drains and replaced some driveway culverts as well. Subdivisions we worked in were Timber Lake, Secrists Subdivision, Thurlow off of Sixty Fourth st. Liberty Park and in the Gardens.
- *The Sheriff notified us of several trees which came down in storms and high winds over the last few weeks. Our crew responded to three and were able to remove two. The third tree split and ended up in a resident back yard. The rest of the tree left standing was near electrical lines and our tree contractor was called for removal.
- * Several residents also called in with work requests to remove fallen limbs from right of way trees due to the winds and storms.
- *Our tree crews diverted from the brush pickup to collect the reported limbs then went right back to picking up brush.
- *We continued using our track hoe with the brush cutting attachment off of 109th St to remove brush on the North and South sides of the road. Both sides of the road were covered with poison ivy and one of our crew members was exposed and ended up breaking out. We also took our hoe to Winfield township and spent a couple days helping them with some of their brush issues.
- * Three years ago, we signed an Alliance with the other eight townships to share equipment, man power and employee expertise in order to help save the residents of our respective townships money. This is a great example of how the alliance works.
